

5. For orphanage, destitute home (Vidhyashrama and Vrudhasharama) and other centers for down trodden and needy members of the society.













To open found, construct, establish, take over equip, promote, conduct maintain support, subsidize grant, aid and make conditions to schools, colleges pathshalas, Hostels, Working Women's Hostels, Reading Clubs, Libraries, Art Music or Literacy Societies and other educational institutions, associations for imparting or developing spiritual commercial industrial, legal, medical, engineering, dental school for Boys/Girls Nursery school, Balawadies community centers etc.,
7. Grant of endowments of universities, Research, Institution for spread of education and knowledge in all or any branches of knowledge.
8. Assisting in the promotion of research and development in various fields land/ or undertaking prosecuting and encouraging higher education and research work in any branch of engineering/medical/law/PHD, Horticulture, Agriculture or any other branch or branches of modern science in its widest and most comprehensive sense.
9. Establishing, maintaining or otherwise centers for research in medical science, veterinary colleges, dispensaries, hospitals etc.,
10. Aiding, assisting, donating, subscribing or otherwise contributing funds of societies, institutions trusts and other funds for promotion of any of the foregoing objects.
11. To help widows, orphans, lunatics indigent persons and the victims of various social evils of the society, and to give relief to the poor and distressed disabled destitute etc.,
12. To build , equip, take over conduct, maintain and grant aids to dispensaries maternity home, hospitals, lunatic asylums or any other institutions of the like nature.
13. To erect and maintain old age homes, poor house, public works etc.,
14. To carry out all such acts and things which are incidental or necessary for the promotions of the aforementioned objects with and other in general.

15. 16. To subscribe to such other charitable objects as the trustees may deem properly provided, however, that the donees in all such cases are recognized under section 80G of the Income Tax Act 1961 at amended from time to time.

NAME OF THE TRUST

This shall be a public charitable trust and the properties, monies and the income thereof shall be solely applied towards the promotions of the objects for which this trust is established and no portion thereof shall be distributed as profit among the trustees and also the authors of the Trust shall not utilize any money for any other purpose other than to achieve objects of the Trust. The trust is entirely of a Charitable nature and the Trustees shall render the services honorary. However, the trustees are free to incur actual expenditure to achieve the objects of the trust with the authorization of the Board of Trustees.

THE BOARD OF TRUSTEES

The board of trustees shall have the power to nominate (Co-opt) additional Trustees and Trustees so (Co-opt) nominated for life shall each hold office for life. All the trustees means and include his heirs, successors. In case any founder trustee chooses to relinquish the office of the Trust, he is empowered to nominate any member of his family or the other Trustee can nominate any person of their choice.

Whereas, pursuant to the above, the authors of the Trust hereby declare a public charitable trust by declaring a sum of Rs. 2,000/- (Rupees Two Thousand Only) as a Trust property and transfers and delivers the same to the Board of Trustees herein hold the same upon trust for the objects herein specified and subjects to the terms and conditions stipulated hereinafter.

APPLICATION OF TRUST PROPERTY AND FUNDS

1. All properties of the Trust including the corpus the addition and accretion thereto and the income there from shall be utilized in for all or any purposes of the trust as set out supra and in such manner and to such extent as the Trustees may from time to time determine.
2. All the monies, which are not immediately required, shall be invested the conformity with the provisions of section 13 of the Income Tax Act 1961.

THE POWER OF TRUSTEES

THE TRUSTEES SHALL HAVE FULL POWER AUTHORITY TO ADMINISTER THE Trust, its properties and affairs and to all such acts deeds and things are as calculated to fulfill objects for which the trust is established.

Without prejudice to the generality of the foregoing, the trustees shall have the following powers for purposes of this trust.

1. To raise funds by contributing donation from the individuals company public or from any other source for the benefit of the Trust or from the Government Agencies, Local Bodies, Co-operative Institutions, Bank/State Finance corporation, Individuals or from other private sources etc.,

2. To acquire by purchase, grant, gift, exchange lease, hire or otherwise lands buildings stocks, shares, securities movables and properties of every other description.
3. To will, mortgage, grants of lease hire and otherwise dispose all properties of the Trust.
4. To enter into all contracts on behalf of the Trust and to receive it.
5. To borrow money with or without security and to repay the same.
6. To open accounts in banks and provide for its operation by secretary only, as may be decided upon by the Board of Trustees from time to time.
7. To invest the funds of the trust for immediate requirement purpose of the trust in such a manner as deem fit, subject to the provisions of the section 108-B of the Income Tax Act 1961.
8. To receive collect and enforce recovery of all monies due or payable to the Trust and to grant necessary receipts and discharge there before.
9. To appoint, terminate suspend and otherwise deal with staff.
10. To appear and represent before courts, tribunals public officers etc., if necessary.
11. To institute, prosecute and defend all suits and other legal proceedings.
12. To incur all necessary expenses in connection with the trust and its management.
13. The board of trustees consists of all the life trustees and nominated co-opt trustees.
14. To make ruled of the trust by complete 3 Trustees.
15. To amend rules and regulations by complete 3 Trustees.
16. There can be special meeting of the Trust by resolution of the Board of Trustees or by written request to complete 3 Trustees of the members of the trust.
17. Notice of every Board of Trustees meeting specifying the date, hours and place of the meetings with the agenda shall be sent to the trustees at least 15 days before the date fixed for the meeting by circulating the meeting notices or by means of post.

18. To adopt the annual report of the Secretary and to approve the audited statement of account for the previous year budget for the next year.
19. The trustees who wish to have any subject placed before the board of Trust meeting shall furnish the same to the secretary in writing not less than seven days before the date fixed for the meeting.
20. All business discussed or decided at the board of trustees, meeting shall be recorded in the proceedings or minute book, which shall be signed by the president/secretary and Board of Trust members.
21. Extra ordinary boards of trustees meeting may be called for by the secretary in consultation with the president or in his absence the Secretary in transact the urgent and important matter.
22. More than fifty percent of the total members at a given time shall be the quorum for the meeting within an hour from the time appointed for the meeting. If quorum is not found, the meeting shall be adjourned to any other convenient date, no notice is necessary for such adjourned meetings.
23. No business shall be transacted at adjourned meeting other than the business left unfinished at the meeting from which the adjournment took place. Such adjourned meeting may proceed even though there is no quorum.
24. To enroll patrons, nominated trustees or in such other capacities as the board of trustees may deem fit and the frame rules for the enrolment and other matters relating to such position.
25. To pay out of the Trust Funds, Salaries, wages, rent for buildings, maintenance etc., relating to the trust and its activities or its order affairs for the management of the trust.
26. To appoint committees, sub-committees, from outsiders and /or among the members of the Board and assign duties and seek suggestions for the purpose of working of the trust and to frame such rules and regulations for the management and administration of the Trust and institutions as the Board of Trustee may thing fit and to alter or vary the same from time to time and to make new rules and regulations which shall not be inconsistent with the terms of these presents.

ELECTION OF THE PRESIDENT/CHAIRMAN, SECRETARY AND INTERNAL AUDITOR.

THE TRUSTEES SHALL ELECT FROM AMONG THEM A PRESIDENT/Chairman, a Secretary, and Internal Auditor who shall hold office for life period.

PRESIDENT/CHAIRMAN AND HIS POWERS

- a) The President/Chairman shall be in overall in-charge of the management of the Trust.
- b) He shall fully supervise and manage the activities and inspect the activities particularly and cause to be inspected the place of activities and business.
- c) He shall recommend to secretary to suspend, remove any staff member for the reason of indiscipline, misbehavior or misappropriation of funds or negligence of duties etc., subject to ratification of Government body.
- d) He shall ensure the finalization of accounts on 31st March every year and get the approval by the Board of Trust.

SECRETARY AND HER POWERS

- a) The secretary whom the General Body elects is purely honorary and she shall maintain all the records, register, references and accounts properly and up to date. She shall open the bank current accounts in the name of above trust and Princeton Public School, apply for all types of loans and she will be the signing authority for all the bank transactions.
- b) She shall be responsible for the proper working and to fix up the duties and responsibilities to the staff members and to manage the affairs and also she shall be the custodian of all the assets records.
- c) She shall be present in all the meetings and shall be responsible to carry out the decision of the Governing body and subcommittee.
- d) She shall fix the date of the meeting of the Governing body or sub Committee and prepare the agenda for the meeting and give notices.
- e) She shall record the proceedings of all meetings and preserve such proceedings.
- f) She shall sign all the bonds and documents etc., and she shall look after the day-to-day financial transactions of the trust.
- g) She shall be responsible to get the account audited by a certified chartered accountant annually and preparations of a monthly receipt and expenditure statements and get it approved in ensuring governing body and also to attend the rectification of the audit observations.
- h) She shall not exceed Rs. 500/- at a time. If it exceeds Rs. 2000/- the approval of the Governing body is necessary.
- i) She shall suspend or retrench any staff members in consultation with the President/Chairman giving one-month advance notice wherever necessary for reason for indiscipline of duties subject to the ratification of the Governing body.
- j) She shall attend or cause to be attending on behalf of the Trust in all judicial proceedings in consultation with the president/Chairman or on the decision of the Governing body.

The accounts shall be audited by a practicing valid chartered accountant as defined in section 288 with explanation mentioned there in.

The audited statement of the accounts, annual reports and budget shall be presented at the time of annual meeting for necessary verification and approval.

The accounts shall be closed by thirty first March every year.

INVESTMENT CLAUSE

The funds of the Trust shall be invested in the modes specified under the provisions of the 80 (F)(IV) of the Income Tax Act, 1961. Too apply and use the funds for all or any of the objects of the Trust and to accumulate the surplus and unapplied portion of the said income under "surplus accounts" and invest the same subject however to complying with the requirements of the Income Tax Act 1961 as amended from time to time to accumulation of Income and investment thereof.

The funds of and income of the Trust shall be solely used towards the achievement of the object and no portion of it shall be utilized for payment of the Trustees by way of profit dividends etc.

The commissioner of Income Tax to satisfy the requirement for qualifying to be organized U/S 80-G of the Income Tax so that the Donors could get benefit of the Tax exemption.

The fund of the trust shall be invested in the modes specified under the provisions of section 13(1)(d) read with section 11(5) of the income tax act 1961 as amended from time to time.

POWER TO REMOVE THE TRUSTEES

AMENDMENT CLAUSE

No amendment to the trust deed or Rules and Regulations shall be made which may prove repugnant to the provision of sec.2 (5) 80(F) and 80G of the Income Tax Act 1961: no amendment shall be carried out without the prior approval of the Commissioner of Income Tax. Subject to clause 12 (a) the Board of Trustees shall be at liberty to add or alter or abrogate any provision of the provisions of the trust other than the objects of the trust in a manner not inconsistent with the objects of the trust laid down in clause (4) of this deed and the provisions of section 80G of the Income Tax Act 1961 as amended from time to time, enabling the Donors to get relief of donation given by them of the trust.

DISSOLUTION CLAUSE

In the event of dissolution or winding up of the trust the assets remaining as on date of dissolution shall under no circumstances be distributed among the Trustees/Members of the Managing Committee/Government Body, but the same be transferred to another existing trust whose objects are similar to those of this trust which enjoys the recognition in the Income Tax Act, 1961 as amended from time to time.




